Terms of Rental Agreement

1. Kitchen privileges are included in rental
2. Cancellation of rental within 3 weeks of booking may result in forfeiture of security deposit.
3. Renter is not entitled to access other parts of the building.
4. Children are to be well supervised. No children are to be outside the building or wandering in other parts of the building.
5. Post is not responsible for personal property of renter.
6. Rentals are for a period of five (5) hours.
7. Hall closes at midnight; premises must be vacated by 12:30 AM.
8. Hall & kitchen must be left clean and trash bagged at the end of event.
9. All extra requests on the day of the affair must be paid in cash at time of request unless there is prior agreement with the hall booking officer.
10. ALL LIQUOR, BEER & WINE ARE TO BE PURCHASED FROM THE POST. YOU MAY SUPPLY YOUR OWN SODA, WATER OR JUICE.
*Absolutely no Liquor, Beer or Wine will be served to any minor under the legal drinking age (21) at any private party. Failure to comply will result in the termination of the event and loss of fees paid.
11. No drinking is permitted on the outside of the building.
12. Failure to comply with this agreement will result in forfeiture of security deposit and negate any further rentals from VFW Post 1923.
